

## Making the Conference More Accessible

NAWA is committed to making our learning spaces welcoming and inclusive to people of all abilities. If you require accommodations or support, please let our staff know. We will do our best to create a supportive learning space for everyone.

#### Captioning

Captioning helps everyone, not just people with hearing loss or deafness. It also supports neurodiverse people who may need captions to help focus, assists people for whom English is not their first language, and aids people with normal hearing who may be participating from a noisy space. The Conference will have live captioning for all our online keynote sessions and automated captioning for workshops. For the in-person Regional Celebrations, automated captions will be displayed for the featured speakers.

#### **Interpretation and Translation**

We are pleased to offer live Spanish interpretation during the online keynote sessions. For online workshops and in-person Regional Celebrations, automated translation services will be offered through <u>Wordly</u>.

#### **Visual Descriptions**

As part of their introductions, we request that Conference speakers share a visual description of themselves and their surroundings. This helps give a person who is low vision, blind, or even someone calling in to a virtual session without video, a little more information about the speaker as well as a sense of space and place.

#### **Sharing Your Pronouns**

Sharing your pronouns is encouraged. By sharing your pronouns even if you feel your gender identification is obvious, you are showing solidarity with others and communicating that you care about getting everyone's pronouns correct. Asking and correctly using someone's pronouns shows respect.

## **Accessibility at Regional Celebrations**

- ► The **Tri-Cities Regional Celebration** will be held in the ADA accessible Gjerde Center in Building H at Columbia Basin College. The north entrance to Building H has a wheelchair accessible ramp, and accessible parking is available in the North H Parking Lot. <u>Columbia Basin College Pasco Campus Map</u>
- ► The **Spokane Regional Celebration** will be held in the Globe Room in Cataldo Hall at Gonzaga University. Cataldo Hall is a single-story building that is accessible by wheelchair. Accessible parking is available in the lot to the east of Cataldo Hall. There are accessible bathrooms, and a privacy room is available. <u>Gonzaga University Campus Map</u>
- ➤ The **Seattle Regional Celebration** will be held at The Museum of Flight. All galleries and exhibits in the museum of fully wheelchair accessible, and there are non-gendered ADA accessible bathrooms. ### **Leveraging Nonprofit Power**

12.5 million Americans are part of the national nonprofit workforce and contribute over 5% to the annual GDP; in Washington state alone, nonprofit workers are a significant part of the economy, culture, and civic society. In fact, Washington's nonprofit sector employs more people than the construction industry. Yet so many nonprofits are facing hard times, feelings of isolation, and real difficulty in their

operations and impact. How can nonprofits grow, thrive, and leverage their power for change? Join Dr. Akilah Watkins, President and CEO of Independent Sector (and a changemaker since the age of 14 when she organized the rehabilitation of a vacant property in New York City) for a dynamic talk and discussion with attendees about her point of view on what the charitable sector needs to truly thrive. Hear what Akilah has heard from her recent national Listening Tour, learn more about what nonprofits can be doing to change systems through advocacy and coalition, and discuss more about important public policy reforms Independent Sector leads.

#### Independent Sector President and CEO Dr.

**Akilah Watkins** leads the only national membership organization that brings together a diverse community of changemakers, nonprofits, foundations, and corporate giving programs working to strengthen civil society and ensure all people in the United States thrive.

With 25 years as a national thought leader, community organizer, and nonprofit executive, Dr. Watkins' expertise includes nonprofit leadership and advocacy, equity in the nonprofit sector, and community development.

Prior to Independent Sector, Dr. Watkins led the Center for Community Progress, the nation's leading nonprofit dedicated to helping state and local governments turn vacant properties into vibrant places. She has served as an executive leader for nonprofit and community development initiatives in the Obama Administration, NeighborWorks America, The Robert Wood Johnson Foundation, Ford Foundation, and the Center for the Study of Social Policy. She holds a Doctor of Philosophy in Sociology from the University of Illinois at Chicago.



### Conspire and Align: Managing for Equity, Sustainability, and Results

Jakada Imani Wednesday, May 15, 9:00am-10:15am



Taken from their new book, Management in a Changing World: How to Manage for Equity, Sustainability, and Results, co-author Jakada Imani of The Management Center will introduce you to a values-centered framework for becoming the manager you aspire to be.

This session is ideal for new and seasoned managers alike. This is an opportunity to learn directly from the co-author and co-creator of a framework developed specifically for social sector managers at this moment, which is our sector's evolution.

Jakada Imani is The Management Center's CEO and co-author of the best-selling book, Management in a Changing World. He is a spiritually-rooted coach and trainer with over 30 years of experience in racial, social, and economic justice movements and organizations. Before stepping into the role of CEO, Jakada was a senior coach and leadership team member at The Management Center, where Jakada supported high-performing organizations to reach new heights, including Stacey Abrams' Fair Fight, California Immigrant Policy Center, and Essie Justice Group. He served six years as Executive Director of the Ella Baker Center for Human Rights, taking over from the center's founder. In his 13 years there, he led

the team to stop the construction of one of the nation's largest juvenile halls—an enormous "Super Jail for Kids." Jakada also led two successful statewide ballot measure campaigns (California's No on Prop 6 in 2008 and No on Prop 23 in 2010). Over the last three decades, Jakada has worked to protect and advance racial and economic justice. In 2013, he received a ChangeMaker Fellowship from the Pacific School of Religion, where he served for two years, leading a center for spiritual and social transformation. Born and raised in Oakland, CA., Jakada is blessed to share his life with his partner Laura and their blended family of 6 powerful and creative children.






